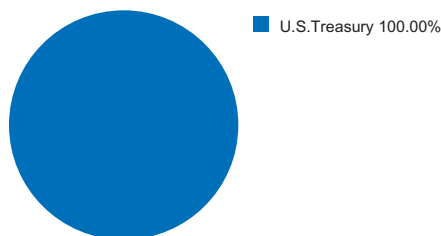

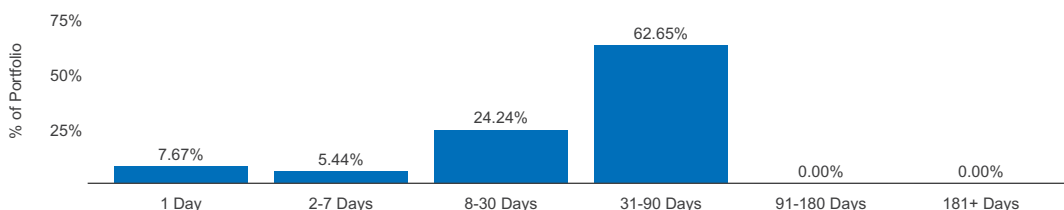

## Fund Goal

The fund seeks as high a level of current income as is consistent with the preservation of capital and the maintenance of liquidity.

## Investment Approach

The fund normally invests at least 80% of its net assets in U.S. Treasury securities, and typically invests exclusively in U.S. Treasury securities.
