

2017 Estimated Spillback Distribution Information

The following funds are projected to make a 2017 spillback distribution. A spillback represents ordinary income and/or capital gain from the previous fiscal year that was not distributed by the end of that year. In general, funds pay distributions for investment activity through the end of October as such funds with fiscal year ending periods after October must distribute gains from investment activity that occurred after October through the end of a fund's fiscal year.

Spillback distributions are taxable in the year received, even though they represent ordinary income and/or capital gains earned by the funds in the previous year. Spillback distributions will be reported to shareholders on Form 1099-DIV, which will mail to shareholders in early 2018.
