## 2018 Federal Tax Information

**Attention Shareholders Subject to the Federal Alternative Minimum Tax:**

The percentage of interest earned by the Fund for the year 2018 from its investment in certain specified private activity bonds which is to be treated as a preference item for purposes of the Federal alternative minimum tax calculation was 17.87%.
